Representative performance

- Represented X Assets Management Co., Ltd. in the case of dispute over transfer of partnership shares with YAO for the amount of over RMB 20 million. After analyzing the fact, the lawyer arrived at an preliminary judgment immediately, raised multiple jurisdiction objections, and responded on court trial, hence eventually forcing YAO to withdraw the case and protecting the client from losses.
